

Reservations and Payment for a PCR Test by Proxy at the Time of Overseas Business Travel

We will start offering the service to business travelers from the companies with business travel contracts from August 3 (Monday)

JTB Business Travel Solutions, Inc., (Head Office: Koto-ku, Tokyo; President & CEO: Masamitsu Shibuya; hereafter referred to as “JTB-CWT”), which provides business travel management and business travel and expense settlement management solutions for the JTB Group, will launch a service to take care of the matters ranging from reservations to payments for PCR tests from August 3 (Monday).

Currently, when going abroad, each country requires travelers to obtain a negative PCR test certificate before leaving the home country. In this situation, JTB-CWT focuses on the step-by-step resumption of global economic activities, cooperates with the Japan Medical & Health Tourism Center, which is the JTB Group’s medical coordinator, and will provide total support for PCR tests for business travelers (a service to take care of the matters ranging from reservations to payments) from August 3 (Monday).

With an eye toward creating an environment where travelers, who are busy preparing for business travel and transfers, will be able to concentrate on their operations, we will provide total support for the procedures associated with reservations for a PCR test and the issuance of a certificate, in addition to arrangements for airline tickets and hotels as well as visa procedures.

We will increase and expand the accepting medical institutions, such as the Tokushukai Medical Group, that can issue a test certificate on the day of the test and travel clinics that can provide medical services related to travel abroad in the future according to the expansion of the resumption of business travel.

Employees of the approximately 3,000 companies that have concluded business travel contracts with JTB-CWT will be eligible for the service, and we will accept requests for the service in conjunction with overseas business travel arrangements, such as overseas airline tickets.

Our branches nationwide that are in charge of JTB Corp.’s corporate business will also offer the same service.

<Flow from Reservation to Payment>

We will accept responsibility for the preparation of an action schedule, which needs to be specified on the negative certificate at the time of overseas business travel, as well as reservations for a PCR test in conjunction with the arrangements for airline tickets and the accommodations associated with overseas business travel by employees of companies that have contracts with JTB-CWT. We will find a medical institution that satisfies the conditions and provide support for the PCR inspection, as well as the matters up to the receipt of a negative PCR test certificate after issuance. Because many countries require the necessary certificate to be issued within 72 hours from the day of going abroad, we will promptly make reservations for the test by proceeding with the procedures in conjunction with the business travel arrangements. In addition, by charging the PCR test cost along with business travel expenses, such as airline tickets, we will realize a one-stop service and eliminate payments by users.

<Persons Eligible for the Service>

The service is limited to overseas business travelers from companies that have concluded business travel contracts with JTB-CWT as of July 30 (Thursday). We do not accept applications from general customers and companies that have not concluded contracts. Because this is a consistent service for total support associated with business travel arrangements, we do not accept applications only for reservations by proxy for PCR tests.

<PCR Diagnosis and Test Fee/PCR Test Result Certificate Issuance Fee>

From 30,000 yen (excluding tax) per person (The amount varies according to the timing and medical institution.)

*A proxy reservation fee will be separately required.
