By installing JIIMA certified software, customers can install the systems securely without confirming whether the system meets the requirements of the Electronic Books Maintenance Act. It also allows customers to skip some items to fill in in the approval request form to submit to the tax office to store electronic data of national tax related books, which reduces the procedures.

Functional specifications of electronic storage software used for national tax related documents in accordance with the Electronic Books Maintenance Act are fairly checked by the third-party organization based on the functions that are publicly shared on instruction manuals, and the certification review committee deliberates following the confirmation that the software is equipped with all the necessary functions, and grants certification. Certified products are publicly shared on the websites of JIIMA and National Tax Agency respectively, and the logo display will be approved.
