Resona Card Added to Business Travel Arrangement & Corporate Card Data Linkage Service J'sNAVI Jr.

— Cards of a total of nine companies can now be used. —

JTB Business Travel Solutions, Inc., (head office: Koto-Ku, Tokyo, president & CEO: Masamitsu Shibuya/hereinafter referred to as “JTB-CWT”), which provides the J'sNAVI Jr. business travel arrangement & corporate card data linkage service of JTB Group, newly starts coordination with Resona Card Co., Ltd., (head office: Koto-Ku, Toyo, president & CEO: Tetsuya Maeda/hereinafter referred to as the “Resona Card”) in linking data on card use.

This service allows J'sNAVI Jr. to aggregate detailed data on the use of a corporate card (for private settlement, corporate settlement, or purchasing*) issued by a card company to link the data with the workflow and expense adjustment system of companies introducing this service in order to enhance efficiency of fare and expense adjustment work.

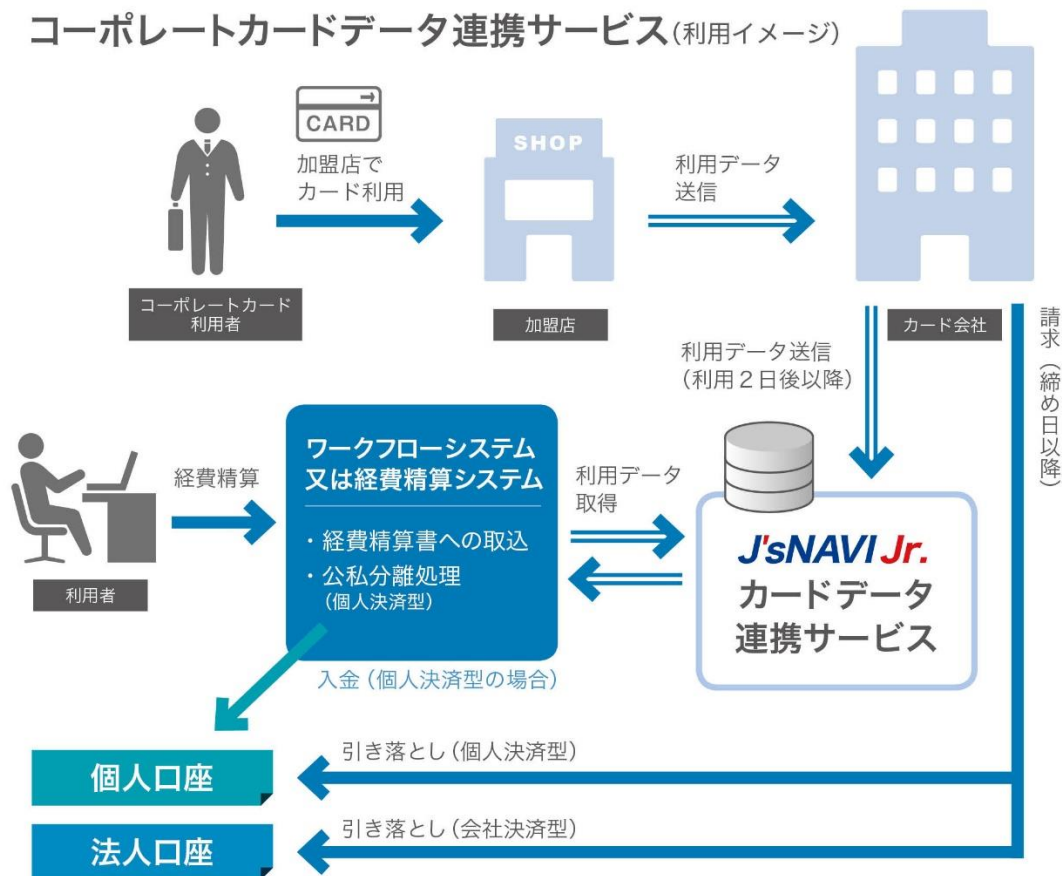
When a user uses a corporate card, detailed use data are automatically loaded to the workflow and expense adjustment system being used so that adjustment processing can be carried out without the user having to manually input data. Because J'sNAVI Jr. can relay and link data to and with each card company through a generic interface, the company introducing this service can link corporate card data more easily.

JTB-CWT coordinates this time with Resona Card so that detailed data on the use of Resona corporate cards that Resona Card issues can be linked via J'sNAVI Jr. with the expense adjustment system you use. J'sNAVI NEO, a cloud-type expense adjustment system conforming to the electronic account book preservation law and provided by JTB-CWT, can hold detailed data on the use of a Resona corporate card without the data being tampered with or altered. It also can search, view, and output data after adjustment processing. Therefore, efficiency of expense adjustment processing can be further enhanced in conformance with the electronic account book preservation law.

*Detailed data on use of purchasing cards of some card companies cannot be linked in some cases.

In addition, data cannot be linked depending on the type and brand of a contracted card.

[Features of the service]

1) Reduces work to input data to or check a fare and expense adjustment report.

By including detailed data on the card used to pay expenses in an adjustment report, the time required to input data during adjustment can be shortened, and the time and effort of an approver for checking can be reduced. At the shortest, the expenses can be adjusted two days after the use of the card by linking detailed data on use with a workflow and expense adjustment system.

(*The timing of linking detailed data on use differs depending on the shop where the corporate card was used.)

By using this function together with the business travel arrangement service of J'sNAVI Jr., fares and expenses can be adjusted easily within a wide range.

2) Data on multiple companies' cards can be linked all at once.

Detailed data on the use of cards of multiple card companies, multiple settlement methods, and multiple brands can be linked all at once in a shared format. Companies that have introduced this service can use the service without having to be aware of the linkage format that differs from one card company to another. Data on cards of a total of nine card companies, including Resona Card, can be linked.

J'sNAVI Jr. is a cloud-type business travel arrangement service that can make the arrangements for plane tickets, bullet train tickets, or hotels in coordination with a workflow and expense adjustment system. More than 200 companies have introduced this service. By introducing this service, fraud prevention and travel cost reduction can be expected through visualization of the details of the arrangements. It can also link detailed data on the use of corporate cards, contributing to the enhancement of the efficiency of business operations, including adjustment of general expenses, as well as fare and transportation expenses. It has coordinated with many workflow and expense adjustment systems on sale in Japan.
