Mitsubishi HC Capital Corporate Card added to J'sNAVI Jr., a business travel arrangement and corporate card data transfer service

- A total of 10 card companies now available -

JTB Business Travel Solutions, Inc., a JTB Group company that provides J'sNAVI Jr., a business travel arrangement and corporate card data transfer service, (headquartered in Koto-ku, Tokyo; President & CEO: Masamitsu Shibuya; hereinafter referred to as "JTB-CWT") will begin providing a card usage data transfer service to Mitsubishi HC Capital Inc. (headquartered in Chiyoda-ku, Tokyo; Representative Director, President & CEO: Takahiro Yanai; hereinafter referred to as "Mitsubishi HC Capital").

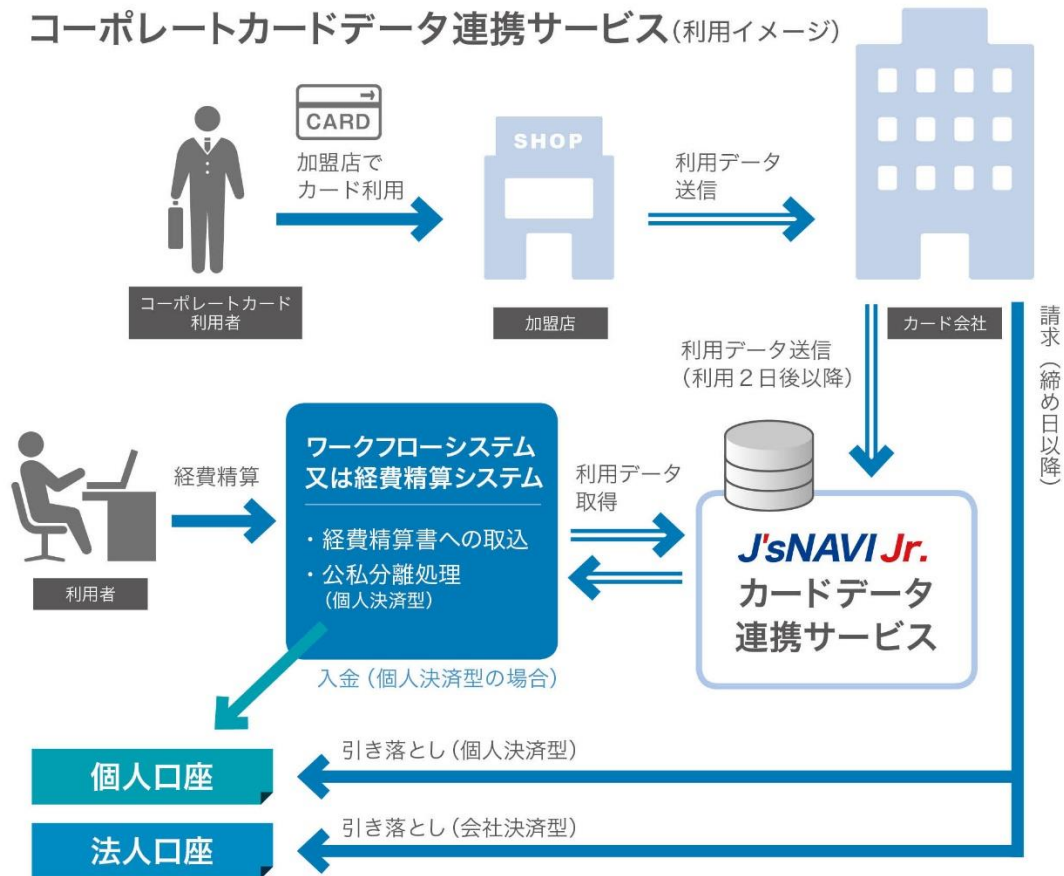
In this service, J'sNAVI Jr. collects and aggregates all detailed usage data from corporate cards (personal settlement type, company settlement type and purchase cards*) issued by credit card companies and transfers it to the workflow and the expense settlement system of the companies that have introduced the service to improve the efficiency in travel and other expense settlement operations.

In addition, detailed corporate card usage data is automatically imported into the client's workflow and expense settlement system, eliminating the need for manually inputting the data by the user. J'sNAVI Jr. relays data from each card company and transfer it via a versatile interface, making it easier for the user companies to use the corporate card data for settlement.

Through this alliance with Mitsubishi HC Capital, the detailed usage data of the Mitsubishi HC Capital Corporate Card issued by the company can be transferred via J'sNAVI Jr. to the workflow and expense settlement system currently used by the Card's user companies. By using J'sNAVI NEO, a cloud expense settlement system that is compliant with the Electronic Book Preservation Act, the detailed usage data of Mitsubishi HC Capital Corporate Card can be retained without tampering or alteration, and the data after settlement can be searched, viewed and output, enabling more efficient expense settlement operations while still complying with the Act.

*The data transfer service may not be available for the detailed usage data of some credit card companies' purchase cards. The data transfer service may not be available depending on the type and brand of your card.

Features of the Service

1) Reducing the workload of inputting and checking travel and other expense data on the settlement form

By importing the detailed data for expenses using corporate cards into the workflow and expense settlement system, the time required for inputting data for settlement and the burden on the approver checking the data can be reduced. At the earliest, two days after the use, the detailed usage data can be transferred to the workflow and expense settlement system and the expenses can be settled.

(*The timing of the transfer of detailed usage data varies depending on the store where the corporate card was used.)

If used with J'sNAVI Jr.'s Business Travel Arrangement Service, a variety of expenses, including business travel and other general expenses, can be settled easily.

2) Able to transfer data from multiple card companies at a time

Detailed usage data from multiple card companies, multiple payment methods, and multiple brands can be transferred at a time in a common format. Client companies can use the service without having to be aware of the difference in transfer formats of different card companies. The total number of card companies that are linked to this service is 10, including this new partner, Mitsubishi HC Capital.

About J'sNAVI Jr.

J'sNAVI Jr. is a cloud-based business travel arrangement service that can be linked to a

workflow and an expense settlement system to arrange air tickets, bullet train tickets, and hotel accommodations. This service has been introduced at more than 200 companies as of April 2022. Visualization of arrangement details helps prevent fraud and reduce business travel costs. Detailed corporate credit card usage data can also be transferred, contributing to the improvement of overall operational efficiency in the settlement of not only travel and transportation expenses but also general expenses. It has been confirmed that the service can be linked to the many workflows and expense settlement systems sold in Japan.

J'sNAVI NEO is an expense settlement system that can work flexibly according to each company's rules. It can support the business travel arrangement function and the corporate card data transfer function provided by J'sNAVI Jr. and handle the entire process from application to approval and business travel arrangement. In addition, it is possible to be linked to transportation IC cards, automatically read vouchers by photographing them with a smartphone application, automatically journalize items, and link to accounting systems, significantly improving the efficiency of expense settlement operations. It is also compliant with the Electronic Book Preservation Act, eliminating the need for physical receipts to go paperless. It is also equipped with a storage function that can meet the storage requirements of electronic transactions, enabling the digitization of any document (new "Document Storage Box" function).
