JTB Single Model Data Transfer Service launched on J'sNAVI Jr., an expense data transfer platform

- A new data transfer system in the Express Corporate Reservation Service -

JTB Business Travel Solutions, Inc., a JTB Group company that provides J'sNAVI Jr., an expense data transfer platform, (headquartered in Koto-ku, Tokyo; President & CEO: Masamitsu Shibuya; hereinafter referred to as "JTB-CWT") will begin offering a new service, JTB Single Model Data Transfer Service, which will enable client companies to automatically transfer their usage data of the Express Corporate Reservation Service, an internet reservation and ticketless boarding service for the Tokaido, Sanyo, and Kyushu Shinkansen Lines for corporate clients, to their existing systems. This service transfers the usage data of the Express Corporate Reservation Service that falls under the categories of "e-reservation only" and "direct settlement method" to the client's system or J'sNAVI NEO, an expense settlement system developed and sold by JTB-CWT, via J'sNAVI Jr. to improve the efficiency in travel and other expense settlement operations.

The JTB Single Model Data Transfer Service enables accurate and fast settlement of expenses by transferring detailed information on the use of the Express Corporate Reservation Service on the day after boarding a Shinkansen train at the earliest.

Benefits of Introducing the Service

- i. Data, including detailed information, such as boarding date, departure/arrival stations, and fare type, can be transferred on the day after boarding a train at the earliest.
- ii. Since the usage data can be used as evidence, it is no longer necessary to bring back a receipt with the boarding sector, fare type, etc. for verification.
- iii. The only difference is that the data is transferred via J'sNAVI Jr. As with the regular Express Service reservations, users can log in directly to the Express website from their PC or smartphone.

*Users must have a contract with the Express Corporate Reservation Service.

*Use of the payment at the time of use method is essential for this service.

*To transfer data to a client's system, a Request for Information Transfer must be submitted in advance.

*Data transfer to a client's system is performed at the client's request. If the data needs to be transferred to systems provided by third parties other than the client and us (e.g., expense settlement systems), the written consent of both the client and the system provider is necessary.

Furthermore, by using the JTB Single Model Data Transfer Service together with J'sNAVI Jr.'s Corporate Card Data Transfer System (which can transfer detailed usage data from 11 credit card companies), expense data other than Shinkansen can be transferred to a client's system together.

In addition, it is possible to be linked to transportation IC cards, automatically read vouchers by photographing them with a smartphone application, automatically journalize items, and link to accounting systems, significantly improving the efficiency in expense settlement operations.
