JTB Business Travel Solutions, Inc. Launches Data Integration Service with "Amazon Business" on Expense Data Transfer Platform "J'sNAVI Jr."

- Simplifying Amazon Business Expense Management –

JTB Business Travel Solutions, Inc. (headquartered in Koto-ku, Tokyo; President & CEO: Masahiro Harada; hereinafter referred to as "JTB-CWT"), a JTB Group company that provides the expense data transfer platform "J'sNAVI Jr.," will begin data integration with "Amazon Business," an e-commerce platform for corporations and sole proprietors provided by Amazon.

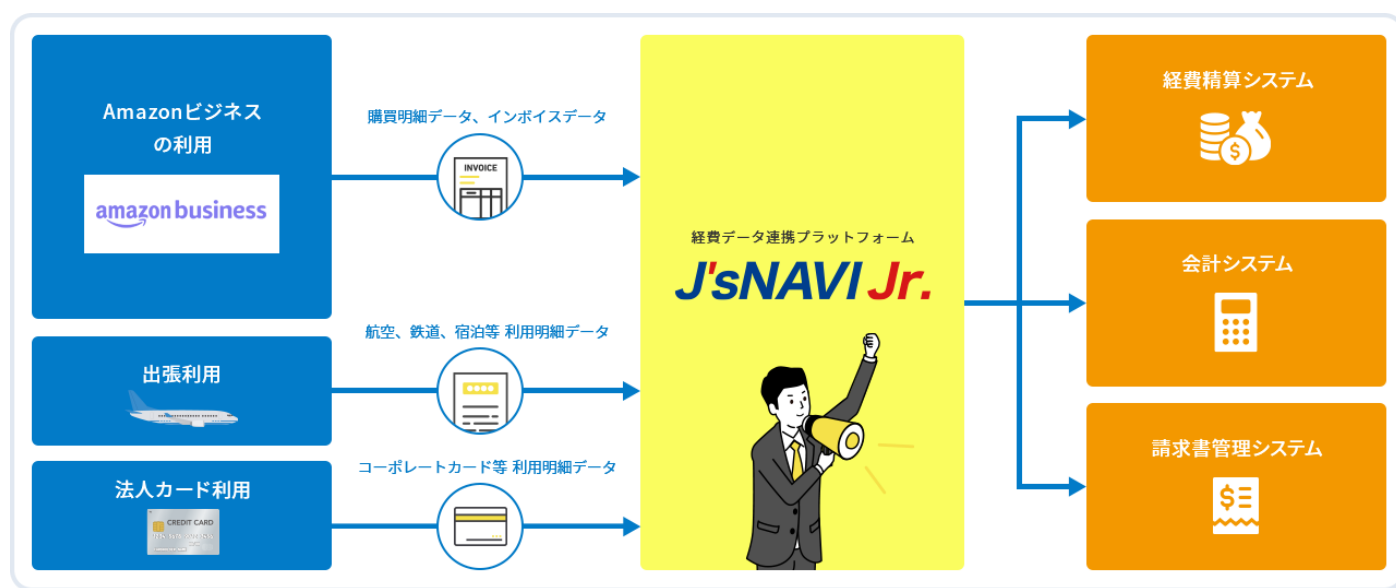
This service enables J'sNAVI Jr. to aggregate purchase detail data and invoice data from Amazon Business and transfer it to the client company's workflow and expense settlement systems, thereby improving the efficiency of expense settlement operations.

J'sNAVI Jr. has been providing business travel data integration and corporate card data integration services in conjunction with multiple workflow and expense settlement systems, with the theme of making expense data integration, which has been time-consuming and costly to develop, easier and more accessible. With the integration of Amazon Business, expense data related to purchasing and procurement will now be available.

Generally, corporate card data does not include detailed information about what was purchased, and in some cases, it is necessary to supplement missing information and attach evidence during expense processing. However, with J'sNAVI Jr., by providing purchase detail data linked from Amazon Business, it is possible to automatically transfer rich data items to workflow and expense settlement systems for expense settlement, even in the case of card payments. Additionally, various data from Amazon Business can be linked as early as the day after shipment.

We also plan to link Amazon Business purchase detail data with "J'sNAVI NEO," a cloud-based expense settlement system that complies with the Electronic Books Preservation Act. This will enable the retention of Amazon Business purchase detail data without alteration or modification, allowing for searching, viewing, and outputting of data after settlement processing, thus achieving further efficiency in expense settlement operations while complying with the Electronic Books Preservation Act.

J'sNAVI Jr. achieves operational efficiency by integrating with various accounting systems that require expense data used in various scenarios, including Amazon Business.



Features of the Service

1) Simple API for data integration

J'sNAVI Jr. enables low-cost expense data integration through general-purpose communication methods and data formats. For data integration with Amazon Business, authentication processing with the required Amazon Business account can be performed on J'sNAVI Jr., minimizing the need for development and modification on the receiving system side. We plan to expand the range of products and services that can integrate Amazon Business data via J'sNAVI Jr. in the future.

2) Integration of two types of data: purchase detail data and invoice data

Two types of data can be integrated: Amazon Business purchase detail data and payment statement data, which serves as the original invoice. The purchase detail data includes detailed items necessary for expense settlement, such as product name, product category, and shipment date, reducing the need for manual data entry. The payment statement data can be stored in workflow and expense settlement systems in accordance with the requirements of the Electronic Books Preservation Act, eliminating the need to download payment statements separately from the web and improving operational efficiency.

3) Integration of business travel data and corporate card data

By connecting to J'sNAVI Jr., it is possible to integrate data from business travel arrangement services and corporate card services in addition to Amazon Business data. These services and various data can be utilized for initiatives such as promoting cashless transactions to reduce out-of-pocket expenses and paperless operations to reduce paper evidence and documents.

About J'sNAVI Jr.

J'sNAVI Jr. is a cloud-based expense data transfer platform that relays business travel arrangement data and detailed card usage data required for expense settlement. As of February 2024, it has been implemented by over 250 companies. Its implementation contributes to the improvement of overall operational efficiency in expense processing by visualizing business travel and other usage expenses, preventing fraud, and reducing

costs. It has been confirmed to be compatible with many workflow and expense settlement systems sold in Japan.
